Who we are and why we matter

St Andrew's First Aid is Scotland's dedicated first aid charity and the country's leading provider of first aid training and event first aid services. Our role is to equip people with the skills, confidence and support to act in an emergency. Our commercial training operation is market-leading in Scotland, delivering high-quality, professionally accredited training at scale.

We deliver our impact through a clear and sustainable dual model. Each year, we train more than 15,000 people in first aid, health and safety and mental health first aid. We work with employers, public sector organisations, schools and individuals across Scotland. Income from our commercial training is reinvested directly into the charity, enabling wider public benefit.

Alongside this, our volunteer network provides first aid cover at events of all sizes, from major national occasions to local community events. More than 700 trained volunteers give their time and expertise, contributing thousands of hours each year to help keep people safe.

As a national charity with reach across Scotland, we are trusted, visible and respected. We combine professional standards with strong community roots, and we are known for delivering high-quality services that make a real difference.

We are focused on the future. Demand for first aid skills is growing, and there is a clear opportunity to extend our reach, influence and impact across Scotland. We are building the capability, capacity and confidence to do more.

What being a charity Trustee involves

Charity Trustees of St Andrew's First Aid play a strategic, non-executive role. Together, the Board provides leadership, oversight and constructive challenge, helping to guide the long-term direction of the charity and ensure it remains well-governed, sustainable and focused on impact.

Charity Trustees are not involved in the day-to-day management of the organisation. That responsibility sits with a capable and experienced Executive Leadership Team. The Board's role is to set direction, support good decision-making and ensure the right frameworks are in place for the charity to succeed.

As a charity Trustee, you will contribute to the Board's collective responsibilities, including:

- Setting and supporting the strategic direction of the charity
- Providing oversight of performance, risk and financial sustainability
- Ensuring strong governance and compliance with legal and regulatory duties
- Acting as a steward of the charity's assets, reputation and values

Charity Trustees are expected to attend four Board meetings each year. Meetings are normally held in person in Glasgow. Trustees may also be asked to contribute to occasional additional meetings, briefings or events where appropriate.

We recognise that being a charity Trustee is a serious responsibility. We also believe it should be a positive and rewarding experience. Charity Trustees are supported through a structured induction, access to information and ongoing development, and a Board culture that values openness, respect and thoughtful challenge.

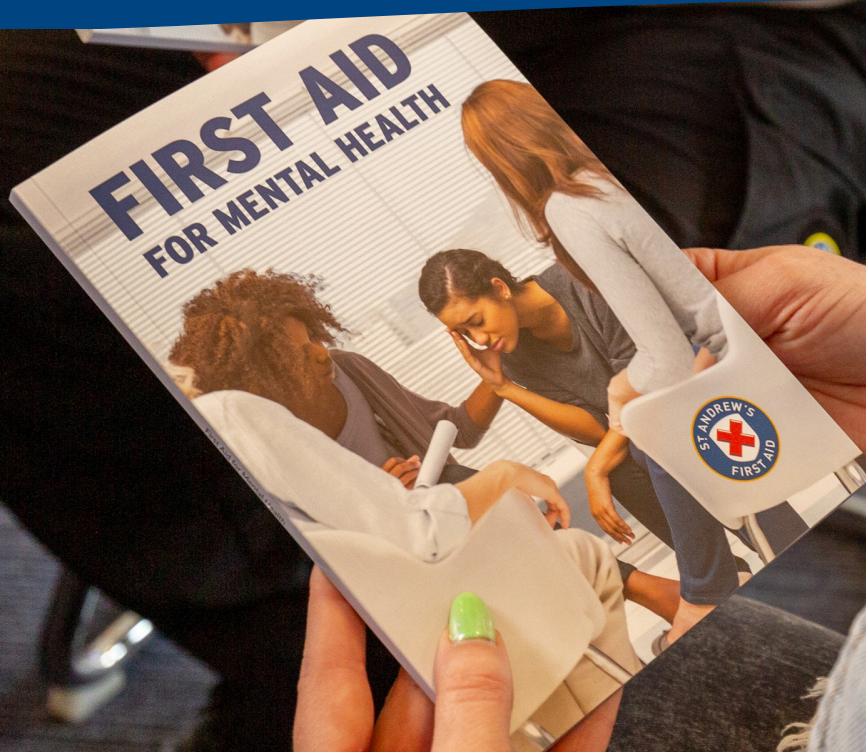
This is a role for people who want to make a meaningful contribution, bring perspective and judgement, and help shape the future of a national charity that saves lives.

Your responsibilities as a charity Trustee

Being a charity Trustee of St Andrew's First Aid carries legal duties which are set under the Charities and Trustee Investment (Scotland) Act 2005. These responsibilities are shared collectively by the Board and are fundamental to ensuring the charity is well governed, accountable and focused on its charitable purpose.

Charity Trustees must always act in the best interests of St Andrew's First Aid. This means making decisions that support the charity's aims, protect its reputation and ensure its long-term sustainability.

As a charity Trustee, you are expected to:

- act with care, diligence and integrity
- act in the interests of the charity, not personal or professional interests
- ensure the charity operates in line with its charitable purposes
- comply with charity law and other relevant legislation
- provide appropriate oversight of finances, risk and performance
- protect the charity's assets, reputation and values
- act collectively and share responsibility for Board decisions

Charity Trustees also have a duty to ensure that St Andrew's First Aid:

- delivers public benefit
- is properly governed and accountable
- meets its reporting and regulatory obligations
- maintains accurate records and transparent decision-making

Charity Trustees are not expected to be legal, financial or operational experts. They are expected to bring judgement, ask questions, seek assurance and take advice where appropriate.

St Andrew's First Aid supports charity Trustees to meet their responsibilities through a structured induction, ongoing guidance and access to senior staff and professional advisers. Appropriate insurance and governance arrangements are in place to support charity Trustees in carrying out their role with confidence.

This legal framework underpins the trust placed in St Andrew's First Aid and enables charity Trustees to make a positive, informed contribution to a national charity that saves lives across Scotland.
